Municipal League Names Chair

SEATTLE – The Municipal League of King County has elected Bradley Meacham as Chair to lead its expanding public role in resolving countywide issues.

"Brad brings valuable perspective to the League," said 2007 Chair Bruce Carter, noting his experience as a journalist and communications professional on the national and international scene. "Brad has played a key role in repositioning the League to play a leading role in regional policy debates involving transportation, land-use planning and governance."

Other elected officers for 2008 include Vice Chair Robert Klein, Secretary Norma Jean Hanson and Treasurer Kristin Peterson. The Municipal League's 2008 Board of Trustees currently includes 32 members.

In addition to its annual evaluations of candidates for public office, the Municipal League studies policy issues and hosts events around the region in order to involve citizens in their government.

Meacham, 34, a King County native, is an employee of Microsoft in Redmond and lives in Seattle's Eastlake neighborhood. His experience includes working as an editor in New York City, as a business reporter in Seattle and as a foreign correspondent based in Japan. He holds a B.A. from Columbia University.
